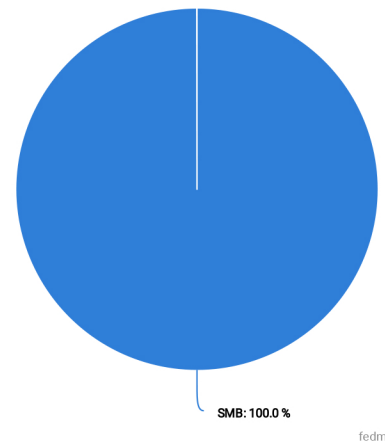
**Top 10 States (Place Of Performance)**
